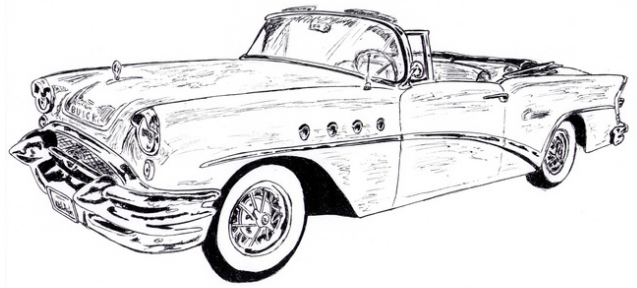

Classic Northbrook Car & Truck Show and CARavan

Bring your classic vehicle to the 26th Car Show that's part of the Northbrook Historical Society's 48th Shermerfest. It's from noon to 4 p.m. in beautiful Village Green Park. You can also join the CARavan that leaves the North Suburban YMCA (2705 Techny Road) at 10:30 a.m.

- ♦ All drivers in both events must sign waivers. ♦ Minimum donation is \$15 per vehicle.
- ♦ Dash plaques to those who contribute at least \$25. ♦ Awards given for visitors' favorites.
- ♦ All vehicles must enter park going westbound on Walters Avenue, and this will be enforced. CARavan usually arrives right around 11 a.m., so those not in it should adjust their schedules. CARavan participants likely will park together in a designated area. All drivers, please be patient when waiting to enter park . . . there are strict Park District guidelines we must follow for parking near the historic trees. ♦ No car entries into park after 1:30 p.m. ♦ No pets or smoking in park.

There will be advance and day-of registration for both the Car Show and CARavan (one registration covers both; no online registrations after Sept. 25). 2. ASSUMPTION OF RISK. I agree to accept and assume all risks and dangers related to my participation in the Event. I understand that the risks and dangers include personal injury and loss and injury, damage, loss or destruction of vehicles and other personal property used by me or owned by me.

3. RELEASE AND WAIVER. By this Release and Waiver, I release, waive, discharge and promise not to sue the NORTHBROOK HISTORICAL SOCIETY, the NORTHBROOK PARK DISTRICT, or any Historical Society or Park District directors, officers, advisors, representatives, agents or employees for any and all liabilities, claims, demands, actions and causes of action relating to or arising out of any loss, damage, or injury of any kind that may be sustained by me, or injury or damage to any vehicle or other property owned by me or in my possession in connection with the Event.

4. BINDING EFFECT. This Release and Waiver is binding on me, my heirs, successors, assigns and personal representatives.

5. SEVERABILITY. I agree that this Release and Waiver is intended to be as broad as permitted by law and, if any portion is invalid, I agree that the balance remains in full force and effect.
