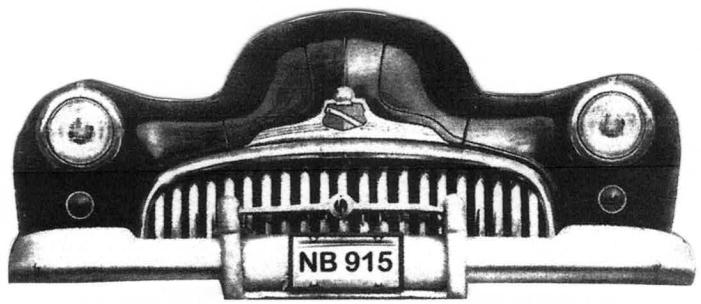

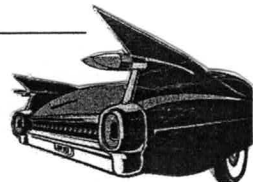

ASSUMPTION OF RISK, RELEASE AND WAIVER OF LIABILITY AGREEMENT

Event: Shermerfest Activities and Shermerfest Car Show ("Classic Northbrook")

In consideration of the **NORTHBROOK HISTORICAL SOCIETY**, an Illinois non-profit corporation, allowing me to participate in the Shermerfest event and the Shermerfest Car Show to be held on Sunday, September 15, 2019, I agree to the following:

1. **PARTICIPATION IN THE EVENT:** I will participate in the Shermerfest event and the Shermerfest Car Show and related activities, including the display of one or more motor vehicles (either owned by me or in my lawful possession), at the Village Green, which is public property belonging to the **NORTHBROOK PARK DISTRICT** and used for this event by the **NORTHBROOK HISTORICAL SOCIETY**.

2. **ASSUMPTION OF RISK.** I agree and understand that there are certain inherent risks and dangers associated with my participation and attendance at the Shermerfest event and the Shermerfest Car Show and I knowingly and voluntarily accept and assume all risk, loss, damage and expense for all personal injuries and all risk, loss or damage to my vehicle or to any vehicle (and including any other related equipment) I bring to or display at the Shermerfest event and the Shermerfest Car Show.

3. **RELEASE AND WAIVER.** I release, discharge and covenant not to sue the **NORTHBROOK HISTORICAL SOCIETY**, its directors, members, officers, advisors, attorneys, representatives, agents or employees ("Released Parties"), with respect to all liabilities, claims, lawsuits and causes of action of any kind arising out of or related to any loss, damage or injury to me or injury or damage to any vehicle or equipment displayed by me, whether caused by the negligence of the Released Parties or otherwise, and relating to or arising out of my attendance at and participation in the Shermerfest event and the Shermerfest Car Show.

4. **BINDING EFFECT.** I agree that this agreement is binding on me, my heirs, successors, assigns and personal representatives.

5. **SEVERABILITY.** I agree that my assumption of risk and release and waiver of liability is intended to be as broad and inclusive as allowed by the laws of the State of Illinois, and if any part of this agreement is found invalid, I agree that all other terms of this agreement remain in full force and effect.

6. **ACKNOWLEDGMENT.** I have read and fully understand this Assumption of Risk, Release and Waiver of Liability Agreement. I am signing this agreement voluntarily. No representations, promises or inducements have been made to me by anyone. I am at least eighteen (18) years old and suffer no impairment. I agree to be bound by all of the above terms and conditions.
